



I, Fr. Luisi, presented the following Rationale for Change of the Mass Schedule to the Pastoral Councils of North American Martyrs and St. Michael Parishes on the evening of February 2, 2010. Following my Rationale for Change I will give a summary of the meeting and the next steps.

Rationale for Change of the Mass Schedule of North American Martyrs and St. Michael Parishes

- There is no perfect Mass schedule. Even Jesus Christ couldn't please everyone. Please pray about the Mass schedule options as there will be a vote to determine which proposal best serves the needs of both parishes.
- Since North American Martyrs (NAM) Church can accommodate 1000 people (with approximately 300 parking lot spaces) and St. Michael Church can accommodate 400 people (with approximately 50 parking lot spaces along with on-street parking), the Envisioning Ministry Team recommended that there be one 4:00 PM Mass at the NAM Church and to discontinue the 4:00 PM Mass at St. Michael. Noting that the highest single Mass attendance total in the 2009 October Count was 425 persons at the 4:00 PM Mass at NAM and noting that the highest 2009 October Count was 155 persons at the 4:00 PM Mass at St. Michael, North American Martyrs Church can easily handle the combined total of 580. This also takes into account the Diocesan Guideline that there should not be duplicate Masses at the same time and that each Mass should at least fill 50% of the seating capacity of that church.
- It was the recommendation of the Envisioning Ministry Team to offer the parishes of North American Martyrs and St. Michael a combined total of **four** Masses per weekend, i.e. one on Saturday at 4:00 PM and three Masses on Sunday morning. Note that this Mass schedule allows four weekend Masses instead of three current weekend Masses (North American Martyrs) or two weekend Masses (St. Michael). Due to the strong possibility of a merger of the two parishes, we need to think collectively of **our** Mass choices which include both church sites instead of North American Martyrs Church versus St. Michael Church.
- Since the proposal is for St. Michael Church to discontinue their 4:00 Mass, it is important to retain at least one Sunday morning Mass. I think it is reasonable and just to consider "A Margin of Mass Displacement" as the new Mass time being no more than one hour before or after the currently scheduled Mass time. In other words, a 10:00 AM Mass-goer at St. Michael might consider going to a 9:00 AM Mass or an 11:00 AM Mass but not a 7:30 AM Mass since that is more than one hour margin of Mass displacement. Following this reasoning, the middle Mass on Sunday morning should be at St. Michael Church.
- Following Diocesan Guidelines, it is important to allow at least 90 minutes between Masses to account for the unforeseen time when the visiting priest may have a car accident, encounter icy road conditions or illness causing a delay or forfeiture of Sunday Mass, requiring the pastor himself to celebrate all three Masses on Sunday morning. In addition, replacement priests may not always be available in the future. This holds true for Fr. Seeger who resides in Pitcairn, retired priests and Benedictines from Latrobe.
- Since many children (whether they be Catholic or public school children) have sports competitions on Sundays as early as Noon, it is important that the last Mass (at NAM) begin no later than 10:30 for the convenience of these families.
- **I thereby propose the following schedule: Saturday 4:00 NAM, Sunday 7:30 NAM, 9:00 St. Michael and 10:30 NAM as the least disruptive schedule for both parishes considering that I am the only priest assigned to both parishes.**
- Under normal circumstances, I will switch with a visiting priest on alternating weeks for the 7:30 Mass at NAM and the 9:00 Mass at St. Michael. This would mean no more than a one hour "Margin of Mass Displacement" for the current 8:30 Mass-goers at NAM and the current 10:00 Mass-goers at St. Michael. It would also allow for me to celebrate the NAM choir Mass at 10:30 each week at which baptisms, scrutinies for the RCIA, and commissioning of liturgical and catechetical ministers can occur.

SUMMARY OF THE PASTORAL COUNCILS MEETING AND NEXT STEPS

After beginning with a prayer service, I handed to each member of both councils a folder with pertinent information, statistics and Diocesan Guidelines regarding changing the weekend Mass schedule. After reviewing the information in each folder to make sure that we all understood the information contained therein, I presented to the councils the Rationale for Change of the Mass Schedule with bullet points justifying my proposal of the Saturday 4:00 PM Mass (NAM), the Sunday 7:30 AM Mass (NAM), 9:00 AM Mass (St. Michael) and the 10:30 AM Mass (NAM). A lively discussion followed with members of each parish making solid points. I had shared with both councils that I was prepared to present **two different Mass proposals** to the councils but that my five-member staff, which includes Pat Cepec of St. Michael Parish, recommended that I present the strongest Mass schedule, namely, the one mentioned above: Sat. 4:00 (NAM), Sun. 7:30 (NAM), 9:00 (St. Michael) and 10:30 (NAM). I explained to the pastoral councils that I would also consider a second proposal, namely, Sat. 4:00 (NAM), Sun. 8:00 (NAM), 9:30 (St. Michael) and 11:00 (NAM). While I preferred the first Mass Schedule, (Schedule A), I could accept the second Mass Schedule, (Schedule B). A passionate discussion

followed with council members giving the pros and cons of Schedule A and Schedule B. In the end when I asked for a vote, the vote was split 8 to 8 mostly along parish lines with few exceptions.

Fear was an evident emotion in the decision-making of both sides. Many North American Martyrs council members were afraid that if Schedule B were accepted with the last Sunday morning Mass being 11:00 that it would be too late for parents with school children competing in sports contests beginning at noon. These council members feared a backlash by these families to the point where they may leave the parish to go to other parishes with a more convenient Mass.

Many St. Michael council members were afraid that since the proposal was to eliminate the Saturday 4:00 Mass at St. Michael, that it was important to have a 9:30 Mass on Sunday instead of 9:00 since they feared a backlash by parishioners to the point where they may leave the parish to go to other parishes with a more convenient Mass. Even though a 9:00 Mass is within one hour of the current Mass time of 10:00, these members felt that a 9:30 Mass was critical to retaining their parishioners.

After many persuasive appeals by certain members of both councils to unify and accept one Mass schedule there was no agreement on which Mass schedule to accept. Even after giving the council members the option of praying about it and meeting again in one week, they all thought it best to put the two proposals to a vote, to which I agreed.

On the weekend of February 20/21, after the Prayers of the Faithful at all Masses at both churches on that weekend, the priest will instruct the persons at the end of the pew to pass down the survey sheets and golf pencils to those eligible to vote. This includes anyone who has received the Sacrament of Confirmation since that person is fully initiated into the Catholic Church. Voting is limited to those who are registered at North American Martyrs Church or St. Michael Church only. There will be only one vote per person and he/she must sign their name on their survey form and write down their envelope number (confirmed children will write their parents' envelope number). The survey forms will be collected by the ushers before the Offertory Collection. Absentee ballots will be printed in the bulletin of both parishes beginning the weekend of February 13/14. I am asking the members of the Envisioning Ministry Team to count the votes. I plan to accept the Mass Schedule that has a **simple majority of votes** (not a two-thirds majority). Note that the members of both Pastoral Councils agreed both upon voter eligibility, the required signature, the absentee ballot and that the simple majority of votes will be all that is required for that particular Mass schedule to be accepted. After the votes are tabulated, I will post the results in the bulletin for a two week period (February 28-March 13) after which both Pastoral Councils will reconvene with me on March 14 at 2:00 in the NAM school library to discuss the survey results/comments from parishioners of both parishes.

Let's pray that there will be acceptance from those in both parishes whose Mass Schedule preference is not selected by the majority of voters. As I mentioned before, I can accept either Mass Schedule A or B. I hope and pray for unity between and among our parishioners so that we can move forward together as a faith community with one endorsed Mass schedule for our parishes.

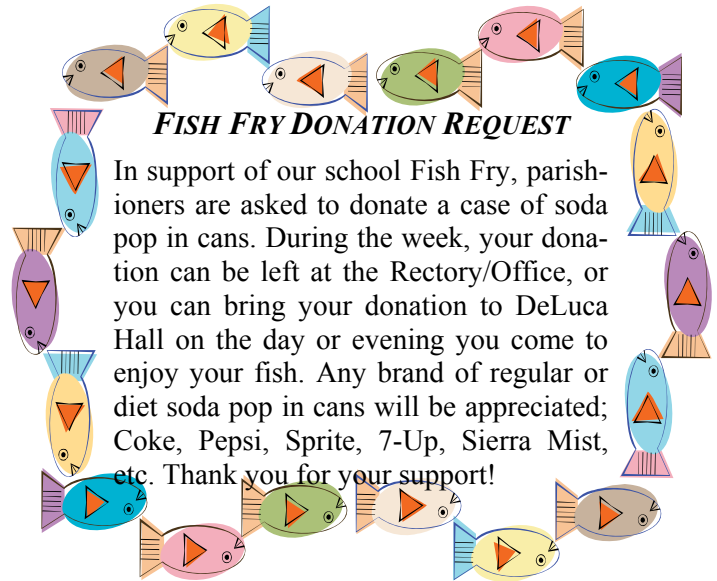
CHILDREN'S LITURGY OF THE WORD is held Sundays during the 10:30 AM Mass for children in Grades 1-6.
